Membership Terms and Conditions**

Definitions

Application:	The Membership Application overleaf.
WEPHL:	Wotton Electric Picture House Limited whose registered office is at 5A Water Lane, Wotton-under-Edge, Gloucestershire, GL12 7LG.
Scheme:	The 'Friends Electric' membership scheme to which this Application relates
Principal Member:	The person signing this Application as 'Principal Member'.
Additional Member:	Any person whose name appears under 'Full names of Additional Members' overleaf.
Member:	The Principal Member and each Additional Member.
Membership:	Membership of the Scheme.
Card:	The card provided to the Principal Member by WEPHL as evidence of Membership.
Annual Fee:	The annual fee payable in exchange for Membership.
Discount:	The reduction in the WEPHL published ticket prices available to Members.
Performance:	A screening or other event provided by WEPHL in the normal course of its business.

Terms and Conditions

By signing the Application overleaf, You confirm that You and all Additional Members have read and understood these Terms and Conditions, including any amendments thereto, and agree to be bound by them.

1. The Scheme is owned and managed by WEPHL.
2. In exchange for the Annual Fee, Members are entitled to the Discounts, as shown in the table overleaf. The Discounts are expressed in monetary terms and are not proportional to published WEPHL entrance prices. For the avoidance of doubt, there is no obligation on WEPHL to change the monetary value of the Discounts in response to any change in its published entrance tariff.
3. WEPHL reserves the right to modify these Terms and Conditions in any way it sees fit by giving Members not less than 14 days Notice (as defined below) of such changes.
4. Notice may be given by WEPHL to the Principal Member by either sending an email to the email address specified in the Application (if applicable) or by letter using standard first class post to the postal address specified in the Application. Notice will be deemed to have been given, in the case of email, 24 hours after the email has been sent and, in the case of first class post, 48 hours after the letter has been submitted to the Royal Mail postal system. Notice given to the Principal Member will be deemed to have been given simultaneously to all Additional Members.
5. WEPHL reserves the right in its sole discretion to reject the Application and return any Annual Fee paid, by giving Notice to the Principal Member. WEPHL is not obliged to give reasons for rejection.
6. Membership is not binding on WEPHL until the latest of the following: -
 - a. The Application is accepted by WEPHL
 - b. WEPHL has given Notice of acceptance by despatch of the Card
 - c. The Annual Fee has been received by WEPHL in cleared funds
7. Discount will only be given for a performance on production of the Card.
8. Discount will only be given for a performance to one or more Members named on the Card.
9. Discounts apply only to regular performances held by WEPHL during its normal opening hours and do not apply to special, one-off or fundraising events unless otherwise stated by WEPHL.
10. The Principal Member must notify WEPHL immediately he or she becomes aware that the Card has been lost or stolen.
11. Membership is for one calendar year ending at midnight on the expiry date printed on the Card.
12. WEPHL may in its absolute discretion cancel and render void the Membership giving whatever notice it sees fit or no notice at all. In such a case, WEPHL will repay to the Principal Member upon surrender of the Membership Card that part of the Annual Fee proportional to the unexpired membership period at the date of cancellation.
13. No Member may cancel Membership early unless WEPHL is in material breach of these Terms and Conditions and, having been given notice of the breach has failed to remedy it within 30 business days of notification. In such a case, WEPHL shall reimburse to the Principal Member a sum proportional to the unexpired membership period starting from the date of the breach.
14. Under no circumstances shall WEPHL be liable to any Member for a sum greater than the Annual Fee.
15. WEPHL reserves the right to confiscate and hold pending investigation any Membership Card it believes to have been misused or otherwise used in breach of these Terms and Conditions.

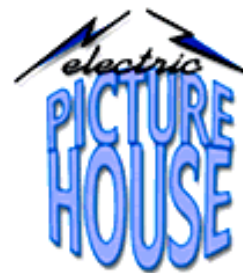

How It Works

‘Friends Electric’ is a Membership Scheme that Gives You Substantial Savings on Entry Prices to All Regular Performances in Exchange for One Low Annual Fee

In exchange for an annual fee, members get discounts on the normal published entrance fee to regular performances (excluding one-off or special events) at the Cinema as follows:

Category	Annual Fee	Discounts
SINGLE 1 full-paying adult 17 years or over	£25.00	Evenings: £1.50
DOUBLE 2 full-paying adults 17 years and over at the same address	£40.00	Matinees: £0.50
FAMILY 1 or 2 full-paying adults 17 years and over PLUS up to 4 children of 16 years and under, all at the same address	£60.00	Children £0.50 for all performances
CONCESSION* (<i>evidence may be requested</i>) One person of 60 years and over One student in full-time education One person registered as unemployed One person registered as disabled	£15.00	Evenings: £0.50 Matinees: £0.50 PLUS: 2 cinema entry vouchers of £4.00 each

* There is no further discount for two or more Concession Members at the same address. You may include more than one Concession Member on this form for convenience, but each will be treated as a separate application.

By way of illustration, the tariff from 16th November 2010 means that members will pay just £5.50 for entrance to all 3D performances and £4.50 for entrance to all other performances.

All you need to do is complete the Membership Application overleaf and return it with your remittance. We’ll send your Membership Card back to you and ‘Job done’. You just show your card every time you come to the Cinema and your discount will be applied. And every penny of your membership fee will go towards ensuring that the Cinema survives and thrives and better serves the Community.
